In compliance with Article 108, of the Public Procurement Law ("The Official Gazette of the Republic of Serbia", No. 124/12, 14/15 and 68/15) and the Report of Bid Evaluation Commission No. 404-02-18/2016-01/8, dated 15 December 2016, the following

DECISION ON CONTRACT AWARD

is made for the Public Procurement of services – "Additional maintenance services, technical support and worldwide support for the aircraft from Government Avio-Service fleet and procurement of spare parts and materials", as the most advantageous bid is selected Bid No. BSL1214110656, dated 12 December 2016, submitted by the Bidder JET AVIATION AG, Flughaffenstrasse, CH-4030 Basel, Switzerland, to whom will be awarded the Contract for the Public procurement of services.

This Decision should be published on the Internet page of the Government Avio Service www.aviosluzba.gov.rs, within three days from the day this decision was made.

CHF or 8.384.188,70 RSD, at the middle exchange rate of the National Bank of Serbia on 15 December 2016 for CHF currency (CHF 114,8519).

7. Rejected bids, reasons for bids' rejection: there are no rejected bids.

II PUBLIC PROCUREMENT PROCEDURE, BID EVALUATION AND RANKING:

Pursuant to Decision No. 404-02-18/2016-01 dated 09 December 2016, was initiated the Public procurement of services - "Additional maintenance services, technical support and worldwide support for the aircraft from Government Avio-Service fleet and procurement of spare parts and materials", pursuant to Article 36, paragraph 1, item 5, subitem 1 of the Public Procurement Law.

The notice on initiation of negotiated procedure without invitation to bid No. 404-02-18/2016-01/4 dated 09 December 2016 was submitted to the interested person, i.e. Bidder who was originally awarded the contract on maintenance services, technical support and worldwide support for the aircraft from Government Avio-Service fleet and procurement of spare parts and materials.

Simultaneously, the notice on initiation of negotiated procedure without invitation to bid the was published on the Public Procurement portal and the Internet page of the Procuring entity: www.aviosluzba.gov.rs, on 12 December 2016, in compliance with all conditions under Article 36, paragraph 7 and Article 57 of the Public Procurement Law.

Bid submission deadline was 15 December 2016 until 12.00 o'clock.

Bid opening procedure was performed immediately upon the deadline expiry, i.e. on 15 December 2016. The procedure started at 12.30 and terminated on the same day at 13.10. It was documented by the appropriate Minutes.

Commission for Public Procurement determined that the bid was delivered to the address of Procuring entity within foreseen deadline, i.e. timely. That is the bid of the Bidder:

There were no untimely received bids.

The authorized bidder's representative nor other persons were present at the bid opening. Minutes on bid opening were submitted in accordance with Article 104, item 6 of the Public Procurement Law.

Upon the Bid opening, on 15 December 2016, the Commission performed a detailed review and expert evaluation of the bid and made the respective Minutes.

In review and expert evaluation, Commission established that the Bid No. BSL1214110656 dated 12 December, 2016, submitted by the Bidder JET AVIATION AG, Flughaffenstrasse, CH-4030 Basel, Switzerland is correct and acceptable since it complies with all conditions of the Public Procurement Law and tender documentation.

During negotiated procedure, Commission established that authorized bidder's representative was not present and that according to that, the final offered price in the negotiated procedure No. P-03/2016 "Additional maintenance services, technical support and worldwide

support for the aircraft from Government Avio-Service fleet and procurement of spare parts and materials" amounted 73.000 CHF or 8.384.188,70 RSD, at the middle exchange rate of the National Bank of Serbia on 15 December 2016 for CHF currency (CHF 114,8519) and made the appropriate Minutes.

According to the above mentioned, the Commission for Public Procurement No. P-03/2016 made Report on expert evaluation No.: 404-02-18/2016-01/8 on 15 December, 2016, proposing to Procuring Entity to adopt the Decision on contract award for "Additional maintenance services, technical support and worldwide support for the aircraft from Government Avio-Service fleet and procurement of spare parts and materials" and conclude the respective contract with the Bidder: JET AVIATION AG, Flughafenstrasse, CH-4030 Basel, Switzerland.

Having in mind the above mentioned and Report on expert evaluation No.: 404-02-18/2016-01/8 dated 15 December 2016 in which the Commission proposed that contract is awarded to the Bidder JET AVIATION AG, Flughafenstrasse, CH-4030 Basel, Switzerland, whose Bid No.: BSL1214110656 dated 12 December 2016 was evaluated as correct, acceptable and timely submitted in the Public procurement procedure, it was decided according to the wording thereoff.

LEGAL REMEDY: The time limit for filing request for protection of rights is 10 days after the Decision on contract award is published on the Public procurement portal.
